CITY COUNCIL RESOLUTION NO. 22-30**

**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF OJAI AUTHORIZING CONTINUED REMOTE
TELECONFERENCE MEETINGS OF THE CITY OF
OJAI PURSUANT TO GOVERNMENT CODE SECTION
54953(e)**

WHEREAS, Government Code section 54953(e), as amended by Assembly Bill No. 361, allows legislative bodies to hold open meetings by teleconference without reference to otherwise applicable requirements in Government Code section 54953(b)(3), so long as the legislative body complies with certain requirements, there exists a declared state of emergency, the following circumstances is met, among others allowed by law:

1. State or local officials have imposed or recommended measures to promote social distancing.

WHEREAS, at its Regular Meeting on October 12, 2021, the Ojai City Council adopted Resolution No. 21-47 finding that the requisite conditions exist for the City Council of Ojai and the City's Boards and Commissions to conduct teleconference meetings under California Government Code section 54953(e), at its Regular Meeting on November 9, 2021, the Ojai City Council adopted Resolution No. 21-50, at its Regular Meeting on December 14, 2021, adopted Resolution No. 21-52; at its Regular Meeting on January 11, 2022, adopted Resolution No. 22-01, and at its Regular Meeting on February 8, 2022, adopted Resolution No. 22-10 finding the same, and at its Regular Meeting on March 8, 2022, adopted Resolution No. 22-13 and at its Regular Meeting on April 12, 2022, adopted Resolution No. 22-16, and at its Regular Meeting on May 10, 2022, adopted Resolution No. 22-24, finding that State or local officials have imposed or recommended measures to promote social distancing.

WHEREAS, Government Code section 54953(e)(3) requires the legislative body adopt certain findings by majority vote within 30 days of holding a meeting by teleconference under Government Code section 54953(e), and then adopt such findings every 30 days thereafter; and

WHEREAS, the Ojai City Council desires to continue holding the City's public meetings by teleconference consistent with Government Code section 54953(e).

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF OJAI DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. Recitals. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.

SECTION 2. Conditions are Met. The City Council hereby finds and declares the following, as required by Government Code section 54953(e)(3):

1. State or local official, including the Ventura County Director of Public Health, have imposed or recommended measures to promote social distancing; specifically, state and local officials require masks indoors for unvaccinated individuals and strongly recommend the wearing of masks indoors for all individuals.
