My several points are presented below. Several statements come directly from the city municipal code.

1. (The need for buffering differing functions) Title 10. Planning and Zoning...lu 10
A) "Require that adequate *buffering* and transitions be provided between dissimilar uses. Where a question of compatibility exists, require the new use to conform to the lower intensity."

2. (Zoning sound/noise standards) Our noise ordinance sets these standards for maximum sound in different zones. 7am to 10 pm residential 55db. VMU 7am to 10pm 55db. Night time for each is 45db
My point here is that residential properties and others in VMU have the same maximum standard numbers.

3. Normal conversation is 55 to 60db. It is important to know that with each 10 decibel increase the sound doubles. A 5 decibel increase is 50% louder. It would be helpful to have a recording of different sound levels to play at such a hearing in the future. As folks gather in numbers (up to 40) the amplitude or loudness increases and pitch or hertz rises. Keeping that down to 55 db and below will be impossible. Monitoring such if approved will require an on site digital decibel monitor with memory for off loading sealed in a secure box with adequate sound opening.

I agree with the planner's conclusion that a rear open patio adjacent to a residential fence and other residences presents sound dynamics which are un-mitigable.

I encourage the PC to reject the staff recommendation and allow the Love Cafe to continue utilizing the outdoor garden setting that was initially authorized for temporary dining due to Covid. This proposed denial by staff is inconsistent with previous projects that involved outdoor dining and other outdoor activities.

The business is located within the VMU zone; and based on my experience the cafe is a quiet and non-intrusive neighbor with limited hours of operation. There are very few properties adjacent to and potentially affected by operation of the cafe.

While we all wish for the global epidemic to end, the virus apparently is not finished with us. It is very possible that we need to continue practicing social distancing and other preventive measures.

I recommend that the Commission urge continuation of the use of the garden area and consider making that use permanent.

It is very surprising that the CUP request by Love Social Café isn't being recommended by the City's Community Development Department to be approved. Just about everybody in Ojai supports and loves this Ojai establishment and have enjoyed their coffee and foods sitting out in the back garden area of the property which is so relaxing and peaceful. What a natural additional seating area for patrons.

It is even more surprising that we aren't encouraging more outdoor eating spaces after all of the COVID challenges we have had and are still facing.... It's the new norm everywhere.

Because the restaurant closes at 2:00 in the afternoon each day, noise affecting a neighborhood really should be a non-issue, especially if the CUP requires this garden area to be closed after hours.

I caught wind of a complaint regarding Love Social's back patio (on social media), but the post didn't specify what the complaint pertained to, it only mentioned that one resident had a complaint and now the situation was "up for review".

I frequent Love Social and value the opportunity to enjoy the back patio, where the tables are farther apart and shaded by trees, where comfortable couches are available and one can have quiet conversations away from the piped-in music played in the cafe area. Although small children sometimes play and babble in that area, their voices blend with the bucolic environment and has never seemed disruptive to me, and I am quite sensitive to "noise". It is a "quiet zone" for collecting one's thoughts when one is alone (and I'm often grabbing a bite by myself). I hope that the person who complained can visit the back patio area to appreciate what a welcome quiet environment this area provides for the cafe's customers. Maybe if the person objects to any "noise" (that may have happened at one time or another) they could visit themselves and perhaps realize that their experience was probably the exception instead of the norm.
