**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OJAI TO UPDATE THE
MASTER FEE SCHEDULE FOR CITY SERVICES**

WHEREAS, the City of Ojai has entered into a Animal Services Agreement with the County of Ventura, approved by the Board of Supervisors; and

WHEREAS, the Animal Services Agreement authorizes the County to provide animal license processing services for the City during fiscal year 2015-16; and

WHEREAS the City Animal Services Agreement requires that the City adopt the license fees set forth in the Ventura County Animal Services approved schedule of rate and fees; and

WHEREAS, the County has conducted a public hearing and adopted the license fees set forth in Exhibit "A" attached hereto.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Ojai that:

SECTION 1. Adoption of Fees

- A. The fees set forth in Exhibit "A", attached hereto, are hereby adopted for animals licensed within the City of Ojai and shall be effective on July 1, 2015.
- B. The fees shall be added to the City of Ojai Master Fee Schedule.
