**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OJAI,
CALIFORNIA, APPOINTING JAMES VEGA AS CITY MANAGER
AND AUTHORIZING THE MAYOR TO EXECUTE THE CITY MANAGER
EMPLOYMENT AGREEMENT ON BEHALF OF THE CITY**

WHEREAS, the Ojai City Council desires to employ the services of James Vega as City Manager; and

WHEREAS, the Mayor and City Attorney have negotiated a proposed employment agreement between the City and James Vega for City Manager services for the City Council's review and approval.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF OJAI,
CALIFORNIA, DOES HEREBY RESOLVE AND ORDER, AS FOLLOWS:**

Section 1. Authority

The City Council has the power to appoint a City Manager under Ojai Municipal Code section 2-3.03.

Section 2. City Manager Appointment

The City Council hereby appoints James Vega as City Manager, under the terms of the employment agreement approved by this Resolution.

Section 3. Approval of City Manager Employment Agreement

The City Council hereby approves the employment agreement between the City and James Vega, attached hereto and incorporated as Exhibit A and made a part hereof.

Section 4. Authorization to Execute Employment Agreement

The City of Ojai authorizes the Mayor to execute the employment agreement between the City and James Vega on behalf of the City.


Section 5. Certification
